



## BR. GABRIEL CONNON AWARD

---

### **Overview**

The Brother Gabriel Connon Award was created by the University's Honors and Awards Committee as a tribute to the late President Br. Gabriel Connon FSC.

The award gives recognition to students with a strong Christian character and outstanding accomplishment in the fields of academics, leadership, and community service. The recipient of this award is envisioned to reflect the essence of the mission statement of De La Salle University-Manila.

### **Qualifications**

To qualify, the applicant must:

1. be a student at the undergraduate level;
2. have a Cumulative Grade Point Average (CGPA) of at least 3.400 with no failing grade;
3. have residency of at least three (3) years at De La Salle University-Manila;
4. be an officer / head of at least one (1) recognized organization on campus for two (2) years, as certified by an SPS Director;
5. be an officer / head of at least one (1) off-campus and/or on-campus community-based\* project for one (1) year, as certified by the head of the sponsoring organization; and
6. possess good moral character and must not have committed any offense (major or minor), as certified by the Director of Discipline.

*\*The community-based projects should be sustainable and have created a major impact in the community.*

### **Application**

To complete the application process, the applicant must submit the following requirements to the Honors and Awards Committee (c/o the Office of the Dean of Student Affairs):

1. Graduation Award Application Form
2. Testimony Form
  - 2.1 Lasallian Character (7)
  - 2.2 Leadership Performance Testimony Form (3)
  - 2.3 Community Service Testimony Form (2 or 3)
3. Certification
  - 3.1 SPS Director
  - 3.2 Head of the sponsoring organization of the community development project
  - 3.3 Director of Discipline
  - 3.4 Certification of CGPA by the Vice Dean (no. of accumulated failures maybe reflected)
4. Information matrices (11 printed copies)



**INSTRUCTIONS TO NOMINEES**

The Graduation Award Application Form (Form No. HAA-02) must be submitted to the Office of the Dean of Student Affairs (SPS 301) on the deadline specified, accompanied by the following:

1. Lasallian Character Testimony Form (Form No. HAA-04) from each of the following:
  - 1.1 Vice Dean or Department Chair;
  - 1.2 an SPS Director;
  - 1.3 the faculty adviser / SPS Coordinator
  - 1.4 a faculty member of your department;
  - 1.5 peer /colleague in the organization (2)
  - 1.6 subordinate in the organization
  
2. Leadership Performance Testimony Form (Form No. HAA-03) from each of the following:
  - 2.1 the faculty adviser of your organization
  - 2.2 SPS Director
  - 2.3 Subordinates in the organization (2)
  
3. Community Service Testimony Form (Form No. HAA-05) from each of the following:
  - 3.1 the head of the sponsoring organization of the community development project or from the COSCA Director or Coordinator for Community Development\*; and
  - 3.2 a member of the organization/project  
*\*If community based project is recognized/authorized by the University*
  
4. Certifications from each of the following:
  - 4.1 SPS Director (Certification of position in recognized organization)
  - 4.2 the Director of Discipline (Certification of good moral character)
  - 4.3 the head of the sponsoring organization of the community development project (Certification of involvement)
  - 4.4 CGPA certification from the Vice Dean (where accumulated failures may be reflected)
  
5. Information Matrices (11 copies) (each subheading below should be in computer printout on a separate sheet(s); items must be arranged chronologically from the most recent; summarize information to show highlights only)
