## 3. MECHANICS

The researcher also noticed that the author used improper language like in the sentence "After the uber tiring and fun experience oh boy you can't blame us for feeling famished."

In the second article, the researcher noticed few errors in the use of punctuation marks. It is either the author forgets to put a comma in a very long sentence or he thought that his readers will read it without pausing. Other than that, the rest of the article was very well written.

In the third article, there are so many errors when it comes to the use of Nouns as if it is countable or not. Instead of using the sentence "This travel blog gives you a rich information of the Philippines ranging from its peaks, countryside and the urban areas." Consider this one "This travel blog gives you rich information of the Philippines ranging from its peaks, countryside and urban areas." The next one is the use of the word "juxtaposely". The researcher looked for its meaning in the dictionary even in the internet but she was not able to find answers.

## 4. TYPE OF ARTICLE

The first and the second articles are considered as a narrative type of article for it was written as if the writers were telling a story or an experience. Both of the articles are short but full of information regarding the mountain.

The third article is considered as a half narrative, informative and backgrounder type of article. It is because this article consists of background information about Mount Malindig as well as informing the public of what and where to go and also telling a story about their experiences climbing Mount Malindig.

## 5. CONCLUSIONS

As presented in the previous part, the first and second article has the same content which is written from personal experiences of the authors. When it comes to the mechanics, the researcher found few errors in the first article mostly on the contractions and the use of punctuation marks while in the second article the author forgets to put punctuation marks especially in very long sentences.
