POLICY STATEMENT

In recognition of the University's responsibility to safeguard and protect the Lasallian Community from all forms of violence and in fulfillment of Republic Act 11053 or the "Anti-Hazing Act of 2018", the University hereby adopts a Zero Tolerance Policy for All Forms of Violence initiated by students, particularly those who are members of recognized and unrecognized student organizations. This policy aims to protect our students and the Lasallian community in general from activities that result in physical and psychological harm.

Further, the University recognizes the right of students to democratically participate in student organizations, alliances, and federations that promote and protect students' rights and welfare pursuant to our collective right to organize and mobilize (Article III, Section 8 of the 1987 Philippine Constitution, otherwise known as the Bill of Rights).

Thus, the University strongly encourages all student-members of recognized and unrecognized organizations to exercise due diligence and utmost responsibility in their democratic participation in organizations, alliances, and federations and in participating in student activities, provided, that no actions result in the contradiction of the University's vision and mission, as well as the state's governing laws.

- 1.2 ____ I am not a member (whether active, inactive, dormant, resigned, dismissed, or otherwise disengaged in any other manner) of any fraternity, sorority, or any organization similar to fraternities and sororities. I also hereby expressly declare that I have not been involved and have not been found liable² in any violent activities and that, if accepted as a student of DLSU, I will not form, organize, recruit, conduct, or participate in fraternity/sorority-related activities in the university during my entire stay. I also expressly declare not to engage in any activities or act in violation of any provisions stated in the Zero Tolerance for All Forms of Violence Policy found in the Student Handbook of the University inside or outside of the campus.
- 2. Violent activities include but are not limited to:
 - 2.1 Hazing refers to any act that results in physical or psychological suffering, harm, or injury inflicted on a recruit, neophyte, applicant, or member as part of an initiation rite or practice made as a prerequisite for admission or a requirement for continuing membership in a fraternity, sorority, or organization including, but not limited to paddling, whipping, beating, branding, forced calisthenics, exposure to the weather, forced consumption of any food, liquor, beverage, drug or other substance, or any other brutal treatment or forced physical activity which is likely to adversely affect the physical and psychological health of such recruit, neophyte, applicant, or member. This shall also include any activity, intentionally made or otherwise, by one person alone or acting with others, that tends to humiliate or embarrass, degrade, abuse, or endanger, by requiring a recruit, neophyte, applicant, or member to do menial, silly, or foolish tasks (Section 2 of RA11053)
 - 2.2 "The intentional use of physical force or power, threatened or actual, against oneself, another person, or against a group or community, that either results in or has a high likelihood of resulting in injury, death, psychological harm, maldevelopment, or deprivation." (WHO)
 - 2.3 Crimes involving VIOLENCE as provided in the REVISED PENAL CODE (RA 3815 as amended) and other special laws.
- 3. I acknowledge and understand that my admission to the University is a privilege and not a right and that the UNIVERSITY has the right and authority to choose the persons or individuals that may be admitted as students of the UNIVERSITY.
- 4. I acknowledge and understand that the UNIVERSITY has likewise the authority to prescribe rules and regulations governing membership of students in any fraternity, sorority, organization, or association, whether within or outside the University, pursuant to its right to establish disciplinary rules and regulations.
- 5. I recognize and accept that my continued stay in the UNIVERSITY is subject to my compliance with prescribed discipline policies, rules, and regulations, especially with what is indicated in Sections 1.1 and 1.2 of this affidavit.
